

#### **United Against Malnutrition and Hunger – Privacy Policy**

Your privacy is important to us at United Against Malnutrition and Hunger. We are committed to letting you know how we use your information and to using your data responsibly. This privacy notice provides information about the different types of personal information that we collect and the ways in which we use it. Please read this policy carefully – by providing us with your personal information, you consent to the collection and use of any information in accordance with this policy. From time to time, and as we grow as an organisation, we may make changes to this policy, and we recommend that you periodically review this privacy notice to be aware of any revisions.

#### Who we are

Alliance to End Malnutrition and Hunger Limited, known as United Against Malnutrition and Hunger (UAMH), is a not-for-profit private company limited by guarantee without share capital, incorporated on 28 July 2022 and registered at First Floor, 10 Queen Street Place, London, EC4R 1BE, United Kingdom (14262345).

Our vision is of a world free from the lasting effects of malnutrition and hunger. To fulfil our mission, we collect data on and bring together leaders from business, finance, research institutions, civil society, the military and diplomatic communities, as well as individual supporters who are united in alarm at the accelerating global crisis of malnutrition and hunger.

## What information we collect, when and how we collect it and how we use it

We may hold personal information relating to you from a number of sources, and will collect personal information about you:

- when you give it to us directly for example, through you communicating with us in person, by email, phone or post, or in attending or participating in one of our events or meetings;
- when we obtain it indirectly for example, your personal information may be shared with us by third parties;
- when it is publicly available for example, through Companies House, Charity Commission and other charity registers, the UK Parliament website, reputable media articles, publications and company websites, and professional networking sites such as LinkedIn. Depending on your privacy settings for social media services, we may access information from those accounts or services, including from Facebook, Instagram, Twitter and YouTube;
- through research if we consider you may be interested in hearing about our work, we may analyse your personal information to create a record of your interests and preferences, to allow us to ensure that communications and invitations to our events are appropriate and relevant. For instance, we look at MPs' voting records and at the activities of international aid campaigners to see if those individuals would be interested to learn about our activities. We may also identify particular politicians in the UK Parliament or business leaders who have shown an interest in aid work in a specific country or countries in order to contact such individuals with information about our work. If you would prefer us not to use your personal information for research please let us know by using the contact details included at the end of this notice.



Depending on how you interact with us, the information that we collect may include your name, home/work address, email address, telephone or mobile number, your organisation affiliations, your social media identity, your contact preferences, and any other personal information which you choose to share with us.

UAMH processes personal data under the lawful basis of consent. In instances where this lawful basis is not sufficient and explicit consent is required, a member of the office will contact you to establish your consent. We are committed to ensuring that the information we collect and use is appropriate for this purpose, and does not constitute an invasion of your privacy.

We will hold this information securely for as long as it is required to fulfil the purpose for which it was collected, after which the personal data will be disposed of securely.

# How we keep your information safe

We make sure that appropriate physical, technical and human controls are in place to ensure we take good care of your information.

However, the transmission of information over the internet is never completely secure and as a result, while we strive to protect your personal information, UAMH cannot guarantee the security of any information you transmit to us, and you do so at your own risk. Once we receive your data, we make every effort to try to ensure its security both on our systems and while in transit between our systems and our partners who work on our behalf. All staff who have access to your personal data understand the importance of keeping your information safe and secure at all times and are given training to support them in this.

We cannot be responsible for the privacy policies and practices of other websites even if you access them using links from our websites and recommend that you check the policy of each site you visit.

We ensure that additional controls are in place for financial, sensitive and special categories of information, meeting regulatory and legal requirements for managing these types of information.
